Deadline for receiving nominations: Sunday, 30 April 2017

Deadline for withdrawing Nominations: Friday, 10 November 2017 before 2Pm in writing.

Date & time of elections: During Annual General Body Meeting (GBM) at ABSICON 2017 at Indian Cancer Congress.

Election Officer (President elect, ABSI) will conduct the election and declare the elected candidates in a separate Session during the GBM titled 'ELECTIONS ABSI'. A nominee of the candidate / candidate himself/ herself may be present during the counting of ballots. The Election Officer (President elect, ABSI) will be assisted by President and Immediate Past President of ABSI in counting of votes during the GBM.

Every ABSI member will have to sign the register before receiving the ballot paper for voting at the Annual General Body Meeting held during ABSICON 2017. Membership cards should be presented for inspection before voting. There shall be no proxy voting. If there is no contest, the Election officer (President elect, ABSI) shall declare the Member elected for the post. If no nomination is received, the President shall nominate a Member for the post.

If the nomination is found invalid, the candidate will be informed by the Election Officer, ABSI about the same and the reason for invalidity mentioned. No member will contest for more than one post at the same time. Every eligible member shall be proposed and seconded by a life member of ABSI. A member can propose or second only one candidate.

Please Note: Nomination form must be accompanied with CV and brief Bio-data.

CV: It must include Publications, Presentations, Conferences organized, ABSI conferences attended in last 3 years & contribution to ABSI.

Brief Bio data: A separate Summary not exceeding 250 words **signed & dated** by Candidate must also be submitted along with the CV & Nomination form. This would be circulated to members before the voting at GBM.

Inadequate information & incomplete Nomination form will result in the Nomination being rejected.
